Thus, the monograph V. Omelyanenko (2017), devoted to the development of theoretical foundations of high technology and development of practical recommendations for improving the model of Ukraine's participation in international high technology transfer taking into account national security, is in demand from the standpoint of modern economics and practically significant.

The monograph is characterized by a systematic approach to research and the use of a set of general scientific and special methods that ensure the validity and reliability of the results.

The author substantiates the conceptual approach to the study of processes by innovation in the global aspect, according to which the international transfer of high technology is a long process, which is considered through

The monograph covers a large information on ICT role in economic development, which is the basis of the new infrastructure of the country and should develop at a faster pace compared to the level of economic development.
